Welcome to my psychotherapy practice. I have been licensed as a Marriage and Family Therapist in private practice in San Mateo since 1991. I am a member of the California Association of Marriage and Family Therapists, the American Association of Marriage and Family Therapists, and I am a certified EMDR practitioner through EMDRIA. I also regularly participate in consultations and trainings, so that I may be of the best service to my clients.

You may use voice mail or email to contact me. I check my messages at least 4 times a day during the week and less on weekends. I only use email with clients to discuss scheduling. I do not provide therapy or consultation via email. If you need to speak to me urgently, please say so in your message. Non urgent phone calls are returned within 48 hours during the normal work days, Monday through Friday. In the event you have a psychiatric emergency, you should call the San Mateo Crisis Line at 579-0350, call 911 or the police; or go to your nearest emergency room.

State law requires a Marriage and Family Therapist to report the following: (1) any reasonable suspicion of child or elder abuse, (2) any specific threat to harm another person or (3) any specific threat to harm oneself. State law allows me to release information in the event that you are a danger to yourself or others. A court order could also require me to release information; however my role is not to testify in court proceedings.

Your fee is \$_____ for each 50 minute session. Please pay your full fee at each appointment. This fee is also the hourly fee for any report writing, court appearances, travel time, and phone consultations/sessions beyond 10 minutes. I prefer cash or check but will take credit cards.

To schedule/cancel an appointment, call (650)348-2797 or email me at mobyrichard@gmail.com. Sessions are typically scheduled one visit per week at the same time & day if possible. **Missed appointments and those cancelled with less than 48 hours notice are charged full fee.**

Psychotherapy is intended to promote personal growth. In some cases, it takes time before people begin to feel improvement. Ethical standards for Marriage & Family Therapists state that a therapeutic relationship only continue so long as it is reasonably clear that a client is benefiting.

You are entering therapy voluntarily and may discontinue at any time. Should you decide to discontinue therapy, please discuss this with me. If you are not benefiting, this will be discussed, and steps will be taken to improve or discontinue the therapeutic relationship. In the event that therapy must end, referrals to other therapists will be provided.
